

PROCEEDINGS OF THE BOARD OF WATERWORKS COMMISSIONERS OF WATER DISTRICT NO. 1, PARISH OF LAFOURCHE, STATE OF LOUISIANA, TAKEN AT A REGULAR MEETING OF THE BOARD HELD DECEMBER 18, 2025.

The Board of Waterworks Commissioners of Water District No. 1, Parish of Lafourche, State of Louisiana, met in regular session at the Water Treatment Plant Distribution Office, Lockport, Louisiana, on Thursday, December 18, 2025, at six o'clock p.m. called to order by Board President, Mr. Sidney Triche.

JOB PROGRESS REPORT

Thursday, December 18, 2025

Waterline Replacement Along Romy Drive

The Contractor has installed approximately 90% of the mainline along Romy Drive. Installation of the mainline, pressure testing and sampling should be complete within the next month.

Back-Up Waterline and Booster Pump Installation at NTP

The 4" waterline has been installed, the pump is installed, and our personnel are currently installing the discharge piping into the existing chlorine feed manifold. This project will be complete within the next month.

Existing Bayou Blue Booster Station Improvements

We received some feedback from the pump vendor, but after some discussion, we determined the proposed pump will not fit our needs, so we are working through some details to fine-tune a selection that will work for us.

Waterline Replacement Along Cheramie Lane, et al

Mainline installation along Marie Street, James Street, and Cheramie Lane are complete. Work will begin on Whitney Lane in the next couple of weeks.

STP - Basin Leak Repairs

This project is complete.

8" Waterline Replacement Along North Dominique Street - CWEF Grant 24-25

Sampey General Contractors is the Contractor for this project. Work will begin once the Romy Drive project is complete.

NEW ADMINISTRATION BUILDING

Notice to Proceed was issued May 9. Current completion date without extensions is December 30, 2026. There are currently seven (7) allowable adverse weather days; however, the Contractor's current project schedule has a April 15th completion date.

Work in progress includes flashing and damp proofing on exterior walls, mechanical and electrical rough-ins, roof trusses installation, site drainage and pavement.

A Request for Change has been submitted due to four (4) additional fire dampers in mechanical ducts as required by the Fire Marshal. The design team has reviewed the cost of \$1,774.66, and it is our opinion that the cost is reasonable. We recommend acceptance of this change order.
