

PROCEEDINGS OF THE BOARD OF WATERWORKS COMMISSIONERS OF WATER DISTRICT NO. 1, PARISH OF LAFOURCHE, STATE OF LOUISIANA, TAKEN AT A REGULAR MEETING OF THE BOARD HELD JANUARY 15, 2026.

The Board of Waterworks Commissioners of Water District No. 1, Parish of Lafourche, State of Louisiana, met in regular session at the Water Treatment Plant Distribution Office, Lockport, Louisiana, on Thursday, January 15, 2026, at six o'clock p.m. called to order by Secretary Treasurer, Mr. Robert Pontif, Jr., in the absence of the President, Mr. Sidney Triche and Vice President, Mr. Eric Roundtree. Mr. Pontif then requested nominations for Chairman Pro Tem. Commissioner Mr. Morris Guidry nominated Commissioner Mr. Nolan Cressionie. After three requests, nominations were closed.

**Thursday, January 15, 2026**

### **Waterline Replacement Along Romy Drive**

Mainline Installation is complete. Chlorination and pressure testing will be complete this week. Service transfers and street tie-ins will begin once testing and sampling is complete.

### **Back-Up Waterline and Booster Pump Installation at NTP**

District staff is installing the plumbing to tie in from the pump to the feed manifold this week. The project should be complete by next week.

### **Existing Bayou Blue Booster Station Improvements**

We received a new pump selection from the pump vendor. Once we are in agreement on the pump we will get pricing to replace both pumps.

### **Waterline Replacement Along Cheramie Lane, et al**

Mainline installation along Marie Street, James Street, Cheramie Lane, and Whitney Lane is complete. Work will begin on the cross street between West 16th and West 17th Street next week.

### **8" Waterline Replacement Along North Dominique Street - CWEF Grant 24-25**

Sampey General Contractors is the Contractor for this project. Work will begin once the Romy Drive project is complete.

### **Waterline Replacement Along Glenn Street, et al**

Muddy Pipeworks, LLC is the contractor for this project. They will begin work on this project once the Cheramie Lane project is complete.

### **Interior Cleaning of Water Storage Tanks - South System**



### PROGRESS REPORT

January 15, 2026

**North Plant 2.0 MG Ground Storage Tank** – Crom finished installing accessories for the tank and is demobilizing the construction crew. The painting crew will be on site the week of January 12<sup>th</sup>. They will start pressure cleaning the tank and then coat the roof and walls of the tank. Once the coating is complete, NCMC will start installing the pipe and valves so they can hydrostatic test the tank while they are installing the rest of the pipe. Project is on schedule.

**North Plant Rapid Mixer and Containment Upgrades** – We are schedule to receive bids on February 22, 2026 on both projects.

**Water System Hydraulic Model** – DSA continues to work on the water distribution system model.
